This panel is offered by Assessment and Treatment Associates (ATA) and satisfies court requirements for a Victim Impact Panel for alleged perpetrators of domestic violence. The purpose of the Victim Impact Panel (VIP) program is to help alleged domestic violence perpetrators realize the long-term effects of domestic violence, to create empathy and understanding of the event(s) leading to arrest, to leave an impression that will change thinking and behavior, and to prevent future offenses from occurring.

Panels give victims a healing opportunity to share their stories in a meaningful way. Victims and survivors of intimate partner violence speak briefly about their personal abuse experience and how it impacts their lives. They do not blame or judge, they simply tell their stories, describing how their lives and the lives of their families and friends were affected by the offenses.
